


Pursuant to Idaho Code 30-1-59 and 30-1-61, we, the undersigned, Shareholders of AARON HOMES, INC. file the following amendments, which were unanimously adopted by the Shareholders and Directors on April 19, 1993.

1. The name of the corporation is Aaron Homes, Inc.
2. The amendments so adopted are changing Paragraph IV of the Articles of Incorporation filed with the Secretary of State in Idaho on October 28, 1992 which reads; The aggregate number of shares which the corporation shall have authority to issue is 100,000, The shares have no par value changing to read; The aggregate number of shares which the corporation shall have authority to issue is 200,000. The shares shall have no par value.
3. The date of the adoption of the amendments by the Shareholders was April 19, 1993.
4. The total number of shares outstanding is 100,000. There is only one class of shares.
5. The number of shares voted for this amendment was 100,000 shares.




