**ARTICLES OF INCORPORATION OF

THE UNDERSIGNED, Acting as incorporators of a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation.

**FIRST:** The name of the corporation is AAROW AUTOMOTIVE, INC.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purposes of the Corporation shall be to provide automotive services.

The Corporation shall further have the power to engage in any and all other types of businesses and business pursuits which may in the opinion of the officers, directors and stockholders be for the general benefit of the Corporation. In carrying out these purposes, the Corporation shall have all lawful powers now or hereafter conferred by the laws of the State of Idaho upon corporations generally.
