We, the undersigned, being respectively a Vice President  
and the Secretary of Saga Corporation, hereby certify:

1. The name of the subsidiary corporation to be merged  
is Saga Administrative Corporation. The name of the surviving  
corporation is Saga Corporation (formerly Saga Administrative  
Corporation).

2. Saga Administrative Corporation is authorized to issue  
1,000 common shares of the par value of \$1 each of which 1,000  
shares are outstanding. All outstanding shares are owned by  
Saga Corporation, the surviving corporation;

3. The certificate of incorporation of Saga Corporation  
was filed with the Department of State on June 17, 1957. Saga  
Administrative Corporation, an Nevada corporation, was incorpo-  
rated on May 17, 1974; no application to do business in New York  
State has been filed by it. The laws of the State of Nevada  
permit a merger such as herein effected.

4. Saga Corporation owns one hundred percent (100%) of the outstanding shares of Saga Administrative Corporation.

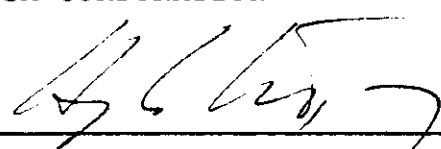
5. The plan of merger has been adopted by the Board of Directors of Saga Corporation, the surviving corporation.

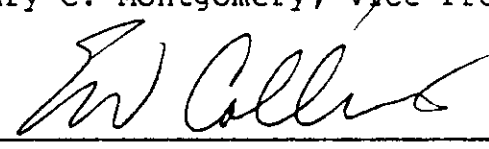

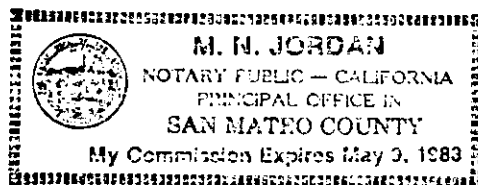
