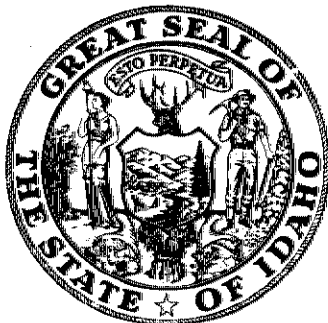

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is WOLFE TRANSPORTATION, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any and all business for which corporations may be incorporated under the Idaho Business Corporation Act, including (a) the purchase, sale, lease, rental and hire of airplanes, (b) the purchase and sale of automotive contracts, and the purchase, sale or lease of automobiles, (c) the sale, purchase or lease of telecommunications and computer equipment, and (d) shall engage in the business of the sale of insurance with the use of agents, brokers or consultants, as provided in Idaho Code 41-1036(4).

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 3,000,000 shares, at no par value per share.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: None.
