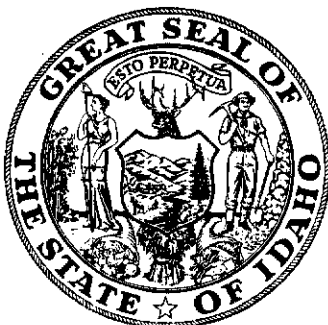

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- FIRST** The name of the corporation is EAGLE POINT, INC.
- SECOND** The period of its duration is perpetual.
- THIRD** The purpose or purposes for which the corporation is organized are: The transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- FOURTH** The aggregate number of shares which the corporation shall have authority to issue is 100,000. The shares shall have no par value.
- FIFTH** The address of the initial registered office of the corporation is 8880 Hess Street, Hayden, ID 83835 and the name and address of its initial registered agent is Patrick Hall, at the same address.


