

ARTICLES OF INCORPORATION

BRIDGEPORT AND HELENA RAIL ROAD COMPANY.

We, W. Thomas Hart, Charles M. Foster and William Miller whose names are hereunto subscribed do hereby associate ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Oregon for the formation of private corporations.

ARTICLE FIRST.

The name of this corporation shall be the Bridgeport and Helena Rail Road Company and its duration shall be perpetual.

ARTICLE SECOND.

The enterprise, business, pursuit or occupation in which this corporation proposes to engage is the construction, maintaining, operating, owning and running a rail road.

ARTICLE THIRD.

That the termini of the Bridgeport and Helena Rail Road shall be as follows;

Beginning at the East or Idaho end of the Oregon Short Line Rail Road Company's bridge across Snake River and known as the "Huntington Bridge"; thence following down the East bank of Snake River passing Mineral City Ferry at seventeen miles, Sturgill Bar at about twenty-six miles, Provoles Ferry at about thirty miles, Dukes Creek at forty-one miles; thence along the mountain side on an ascending grade along the South side of Indian Creek Valley to the North-east corner of Section seventeen (17), in Township twenty (20) North, of Range three (3) West of Boise Meridian, State of Idaho.

ARTICLE FOURTH.

The principal office and place of business of this corporation shall be at Ontario, Malheur County, State of Oregon.

ARTICLE FIFTH.

The capital stock of this corporation shall be Five Million (5,000,000.00) Dollars.

ARTICLE SIXTH.

The capital stock of this corporation shall be divided into Five Thousand Shares and the par value of each share shall be One Thousand Dollars.


