## ARTICLES OF INCORPORATION

OF

## MESA ENTERPRISES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

#### Article I

NAME. The name of the corporation is Mesa Enterprises, Inc..

#### Article II

DURATION. The period of its duration is perpetual.

## Article III

PURPOSE. The purpose for which the corporation is organized is:

- l. To engage generally in the business of farm operation, including the raising of crops and all kinds of farm produce; to engage in the raising of livestock; to acquire farm properties and other real estate by purchase, lease or otherwise and to improve the same, and to acquire by purchase, lease or otherwise all types of farm machinery and equipment; and to carry on generally such other incidental businesses as may be appropriate to the above mentioned activities.
- 2. To engage in the transaction of any and all other lawful business for which corporations may be incorporated under the provisions of Chapter I, Title 30 of the Idaho Code or any amendments or supplements thereto.

#### Article IV

STOCK. The aggregate number of shares which the corporation shall have authority to issue is 250. Said stock shall be of one class designated as common stock with a par value of \$100.00 per share.

#### Article V

REGISTERED OFFICE AND REGISTERED AGENT. The address of the initial registered office of the corporation is Route 1, Parma, Idaho 83660, and the name of its initial registered agent at such address is Ron J. Sali.

#### Article VI

<u>DIRECTORS</u>. The number of directors constituting the initial board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
