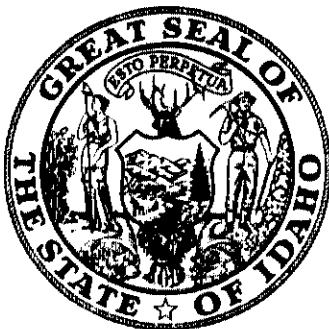
CERTIFICATE OF AMENDMENT OF






