# ARTICLES OF INCORPORATION OF TOM WILKES & SON, INC.

# KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, THOMAS E. WILKES, ILA M. WILKES and RICHARD T. WILKES, all of whom are natural persons, and citizens of the United States of America, over the age of twenty-one years, this day have voluntarily associated ourselves together for the pump ose of forming a private corporation under the laws of the State of Idaho, do hereby make, execute and publish the following Articles of In-corporation, to-wit:

# ARTICLE I NAME

The name of this corporation shall be TOM WILKES & SON, INC.

### ARTICLE II

### DURATION

The duration or term of existence of this corporation shall be perpetual from and after the date of issuance of the certificate of its incorporation by the Secretary of State of the State of Idaho.

#### ARTICLE III

### REGISTERED OFFICE

The location and post office address of the registered office of this corporation in the State of Idaho shall be Boise, Ada County, Idaho.

#### ARTICLE IV

### AUTHORIZED SHARES

The total authorized shares of this corporation shall be Two Hundred and Fifty Shares, having a par value of ONE HUNDRED (\$100.00) DOLLARS per share, making an aggregate of TWENTY-FIVE THOUSAND (\$25,000.00) DOLLARS. The shares of this corporation shall not be

issued until fully paid for, and after issuance, shall not be subject to assessments.

#### ARTICLE V

# DIRECTORS

The business of this corporation shall be managed by a Board of Directors. Each director may, but need not necessarily, be a stockholder in this corporation.

The first Board of Directors shall consist of three members, and succeeding boards may consist of such larger number as may be designated and approved by the stockholders at any regular annual meeting or any special meeting called for that purpose.

Meetings of the Board of Directors may be held either within or without the State of Idaho, and at such times and places as the Board of Directors may, from time to time, designate.

The Board of Directors shall have the power to repeal and amend the By-Laws of, and adopt new By-Laws for, this corporation.

#### ARTICLE VI

# PURPOSES

- (1) To engage in the retail and wholesale sale of auto parts and accessories.
- (2) To manufacture, purchase, import, or otherwise acquire, sell, rent, repair, take upon storage, exchange, export, and otherwise deal in and dispose of any or all of the following: motors, engines, or other machinery or contrivances for the generation of steam, electricity, gasoline or other forms of power now known or which may be hereafter discovered; automobiles, cars, trucks, carriages, wagons, boats, airplanes and airships, and vehicles of every kind and description for the transportation of passengers or goods; machinery, machine supplies, and engineering appliances, hardware, tools, parts, batteries, selfstarters, magnetos, igniters, tires, rims, wagon and carriage bodies and all other accessories, apparatus, and appliances; and fuel, oils, and other materials useful in connection with the ownership, use, or enjoyment of any of the above.
- (3) To buy, sell, trade and deal in gasoline, oils, greases, or other fuel and lubricants, for automobiles, motor trucks, motorcycles, tractors, and other motor vehicles.
- (4) To manufacture, buy, sell, deal in, operate, and let for hire, automobiles, motorcycles, and motor vehicles of every kind, nature, and description.
- (5) To buy, sell, and generally deal in tires for automobiles, motorcycles, bicycles, and vehicles of all kinds and descriptions, whether the said tires be made of rubber, metal composition, or other material or combination of materials; to design, manufacture, buy and

sell, import and export, supplies and accessories for automobiles, motoracycles, bicycles, carriages, automobile trucks, and tractors of every make; to repair, reconstruct, and overhaul automobiles, motorcylcles, bicycles, carriages, automobile trucks, and tractors, of all kinds and makes; and generally to manufacture, buy, sell, and deal in all goods, wares, and merchandise necessary or incidental to the operation, repair, storage, maintenance, or equipment of automobiles, motorcycles, tractors, or motor vehicles of any and all kinds, manufactures, and descriptions.

- (6) To manufacture, purchase, sell, vend and deal in products at wholesale or retail, of all kinds or nature which may be ordinarily dealt in by garages, service stations, and retail stores servicing the public, and conducting a general retail sales business to the public of all goods, wares and merchandise which may become appurtenant or inciedental to the purposes set forth in paragraphs (1) and (2) above.
- (7) To buy, sell, deal in lands, buildings and machinery of every kind and nature for the proper operation of the purposes set forth in paragraphs (1), (2) and (3) above, and all lines incidental thereto.
- (8) To purchase, or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, hypothecate, pledge or otherwise dispose of, to guarantee, and to invest, trade and deal in and with personal property of every class and description.
- (9) To purchase, or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, hypothecate or otherwise dispose of, and to invest, trade and deal in and with real property and any and all interests therein.

- (10) To enter into any kind of contract or agreement, bonus or profit—sharing plan with its officers and employees that the corporation may seem advantageous or expedient, or otherwise to reward or pay such persons for their services as the directors may deem fitting.
- (11) To purchase, lease, or otherwise acquire, in whole or in part, the business, goodwill, rights, franchises and property of every kind, and to undertake the whole or any part of the assets or liabilities of any person, firm, association, partnership or corporation engaged in or authorized to conduct any business similar to any business authorized to be conducted by this corporation, or owning property necessary or suitable for its purposes, and to pay for the same in cash, in stock of this corporation, or otherwise; to hold or in any manner dispose of the whole or any part of the business or property so acquired; and to exercise all the powers necessary or indicental to the conduct of such business.
- (12) To borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, hypothecate or convey in trust any or all of the property of the corporation to secure the payment thereof.
- (13) To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, state, municipality, government, or any subdivision, district, department, agency or instrumentality thereof.

- (14) To acquire and pay for in cash, shares of stock or notes of this corporation or otherwise, the assets, including the goodwill, of any persons, firm, partnership, association or corporation, and to undertake or assume the whole or any part of the obligations or liabilities thereof.
