The place of its principal office is Burley, Idaho. 2. The meeting of the directors of this corporation at which the dissolution was authorized was held December 4, 1978, and a meeting of the stockholders of this corporation at which this dissolution was authorized was held December 4, 1978. Notice of the meeting was waived by all of the shareholders of the corporation. 4.
