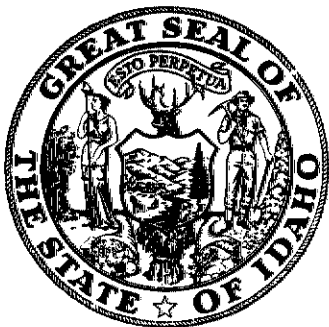

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF V.O.T. SYSTEMS, INC.

Pursuant to the provisions of §30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is V.O.T. Systems, Inc.
2. The following amendments to the articles of incorporation were adopted by the shareholders of the corporation on May 11, 1994 in a manner prescribed by the Idaho Business Corporation Act:


Substitute the existing Article IV with the following: The corporation shall have the authority to issue 2 shares of stock, no par value.

Substitute the existing Article VI with the following:- The address of its initial registered office is 683 North Capital Avenue. The name of its initial registered agent at such address is Kevin T. Sullivan.

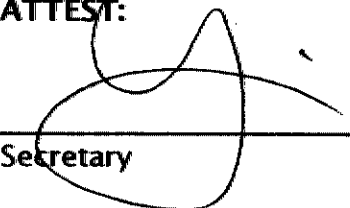
Substitute the existing Article VII with the following: The number of directors constituting its initial board of directors is one, whose names and addresses is: Verl O. Terry, 2647 South 60 East, Idaho Falls, Idaho 83406.

3. There were no outstanding shares of the corporation at the time of the adoption of the amendment, and the number of shares entitled to vote on the amendment was one (1).
