6. The Partnership shall terminate on December 31, 2030, unless previously terminated by the terms of the Limited Partnership Agreement or by operation of law.

7. The General Partners and the Limited Partners have not agreed to make any additional contributions to the capital of the Partnership.

8. There is no time agreed upon as to when the contribution of each Limited Partner is to be returned other than on the termination of the Partnership.

9. The profits and losses of the Partnership shall be allocated as follows, unless the conditions of (a) below are met:

	<u>General Partners</u>	<u>Limited Partners</u>
From formation of the Partnership until cash distributions to Limited Partners equal 100% of the Limited Partners' investment	2%	98%
After cash distribution to Limited Partners equals 100% of The Limited Partners' investment	30%	70%

(a) Allocations will be made as set forth upon the occurrence of the following events:

(i) If the City of Boise exercises its option to acquire the Partnership's interest in a Lease between the Partnership and the City of Boise dated August 25, 1980, and the Limited Partners have either received cash distributions or the proceeds of the sale will be used to distribute cash to Limited Partners to equal 100% of their investment, then profits and sales proceeds in excess of the amount necessary to return 100% of the Limited Partners' investment will be allocated 40% to the General Partners and 60% to the Limited Partners; or

(ii) If the Partnership is able to obtain a loan, the amortization of which will be at least 5 years, which is either guaranteed by the federal or state government or an agency thereof or is at a rate equal to or less than the prime rate of interest charged by the Idaho First National Bank, Boise, Idaho at the time of the advance, and the Limited Partners have either received cash distributions or the proceeds of such loan will be used to distribute cash to Limited Partners to equal 100% of their investment, then cash distributions in excess of the amount necessary to return 100% of

the Limited Partners' investment will be allocated 40% to the General Partners and 60% to the Limited Partners.

10. A Limited Partner must obtain the prior written consent of the General Partners to an attempted assignment of all or any portion of his or her partnership interest. A Limited Partner has no right to substitute an assignee in his or her place, but an assignee of a limited partnership interest may become a substituted limited partner provided that all of the following events shall first have occurred:

a. An executed and acknowledged written instrument of assignment has been filed with the Partnership stating that the assignee becomes a substituted limited partner;

b. The assignor and assignee have executed and acknowledged such other instruments as the General Partners may deem necessary or desirable to effect such substitution including a special power of attorney; and

c. The General Partners have given their written consent to the substitution.

11. The Partnership has the right to admit additional Limited Partners.

12. No Limited Partner shall have priority over other Limited Partners as to contributions or compensation by way of income.

13. The withdrawal or adjudication of bankruptcy or insolvency of either General Partner shall cause the dissolution or termination of the Partnership unless a majority in interest of the Partners elects a successor general partner which successor elects to continue the Partnership business.

14. A Limited Partner may not demand and receive property other than cash from the Partnership in return for his or her capital contribution.

15. This Certificate may be executed by and any writing to amend this Certificate may be executed by either of the General Partners as attorney-in-fact for all Limited Partners and their assignees, in accordance with the powers of attorney granted to and by the Limited Partners.

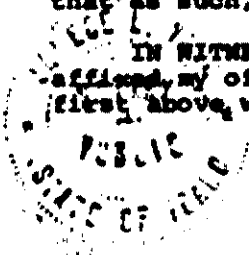

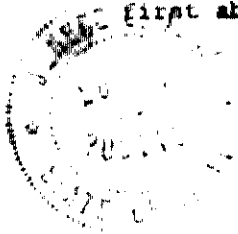
