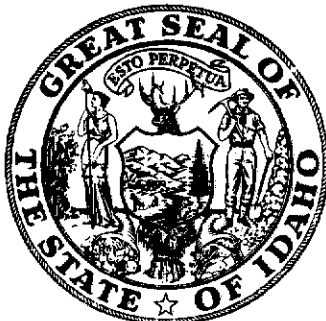

ARTICLES OF INCORPORATION
OF

Door-To-Door Hardware Sales, Inc.

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Door-To-Door Hardware Sales, Inc. (hereafter called "Corporation.")

ARTICLE II

The purposes for which this Corporation is organized are as follows:

1. To engage in retail and wholesale sales and repair; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

All shares of stock shall have the same rights in such Corporation and shall be nonassessable when paid in full.
