Articles of Incorporation (Non – Profit) Addendum (Articles 2 and 8)

Article 2: The purpose for which the corporation is incorporated is:

The Boise Veteran's Wellness Center and Gallery is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code, or corresponding sections of any future federal tax code. Our purpose is to serve veterans with empirically validated and low-risk, complementary therapies, and to promote the therapeutic value of art and creativity.

Article 8: Upon dissolution the assets shall be distributed:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state and local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
