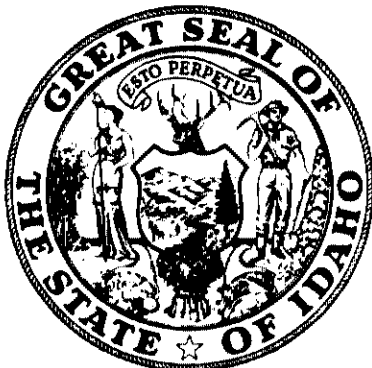

VIII. The contributions of all Partners to the

debts of the Partnership and only out of the net assets
or net proceeds remaining thereafter.

IX. The profits and losses of the Partnership will be allocated 99% to the Limited Partner, .9% to the Individual General Partner and .1% to the Corporate General Partner.

X. The Limited Partner may not substitute an assignee as a Limited Partner in his place without the written consent of the General Partner.

XI. The General Partner does not have the right to admit additional Limited Partners without the prior consent of the Limited Partner.

XII. There is no right of priority among the Limited Partners as to contributions or as to compensation by way of income.

XIII. Upon the bankruptcy, insolvency or dissolution of the Corporate General Partner or upon the death, retirement or insanity of the Individual General Partner, all of the remaining Partners may elect to continue the business of the Partnership and appoint a new General Partner(s).

XIV. No Limited Partner may demand or receive property other than cash in return for his contributions.

XV. Each General Partner, acting singly, shall have the full power and authority to bind the Partnership.
