ARTICLES OF INCORPORATION **SECRETARY OF STATE**

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, the President and Secretary respectively of IDAHO NURSES ASSOCIATION, INCORPORATED, an Idaho corporation, do hereby certify as follows:

That IDAHO NURSES ASSOCIATION, INCORPORATED is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho;

That at the Annual Meeting of the Members of IDAHO NURSES ASSOCIATION, INCORPORATED, held on the 24th day of October, 1986, at Coeur d'Alene, Idaho, at which said meeting more than a quorum was present (this being a nonstock member corporation) a Resolution was regularly proposed, voted upon and adopted by a majority of all of said members, amending the Articles of said corporation, and that the following is a full, true and correct copy of the Resolution of said members amending the Articles of said corporation, to-wit:

" RESOLUTION

BE IT RESOLVED, That the Articles of Incorporation of IDAHO NURSES ASSOCIATION, INCORPORATED be and the same are hereby amended as follows:

Article FOURTH is hereby amended to read in its entirety as follows:

That the term for which said corporation shall exist is perpetual.
