Transportation, Corp. under the provisions of Title 30, <u>Idaho Code</u>, hereby certify the following ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION OF B.C. TRANS-PORTATION, CORP, have been affected by RESOLUTION, pursuant to <u>Idaho Code</u> 30-1-59 and that said Amendments are as follows:

WHEREAS, shares have been issued in said Corporation;

Now, THEREFORE,

Upon motion duly made, seconded and unanimously carried, it is resolved:

That ARTICLE IV of the ARTICLES OF INCORPORATION OF B.C. TRANS-PORTATION, CORP. be changed as follows:

ARTICLE IV

Authorized Shares

Section 4.01. The corporation is authorized to issue only one (1) class of stock; the total number of which is FIFTEEN THOUSAND (15,000) shares of common stock, at no par value.

and further state that the Amendment so adopted is as hereinabove set forth, that the date of adoption of the Amendment by the directors and the ratification of said Amendment by the shareholders, all exemplified by affixing their signatures hereto, was November 1, 1982, that shares have been issued or are outstanding or entitled to both thereon, and that said Amendments do not provide for an exchange, reclassification or cancelation of issued shares, and that said Amendments do not affect a change in the amount of stated capital, AND FURTHER STATE that no others Articles of the original ARTICLES OF INCORPORATION are changed or affected other than ARTICLE IV as hereinabove set forth.
