ARTICLES OF INCORPORATION

OF

M.R.A. PLANNING SERVICES, INCORPORATED

TO SEC 30

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is M.R.A. PLANNING SERVICES, INCORPORATED.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the Corporation is organized is to provide personal financial planning services relating to business and financial matters and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 100,000 at \$1.00 par value.

FIFTH: The holders of shares of stock in this Corporation are not entitled to preemptive rights to purchase additional shares of stock.

SIXTH: The transfer of the shares of the Corporation are restricted and such restriction shall be noted on the back of each outstanding certificate as follows:

"Any sales, assignment, transfer, pledge or other disposition of the shares of stock represented by this certificate is restricted by, and subject to the terms and provisions of a Stock Redemption Agreement dated

A copy of said Agreement is on file with the Secretary of the Corporation. By acceptance of this certificate, the holder hereof agrees to be bound by the terms of said Agreement."

SEVENTH: The address of the initial registered office of the Corporation is 404 South 8th Street, Suite 370, Boise, Idaho 83702, and the name of its initial registered agent at such address is MARK ROBY.
