KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being of full age and citizens of the United States have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify in writing as follows:

ARTICLE I

Name

The name of said corporation shall be Magic Valley Motor Speedway, Inc.

ARTICLE II

Purposes and Powers

The purposes for which this corporation is formed, and the powers this corporation shall have are as follows:

- 1. To carry on, conduct and engage in the business of promoting, holding, overseeing and managing motorized-vehicle races, horse races, chariot races, concerts, rodeos, circuses and any and all other outdoor activities of a similar nature, and to do all things reasonably related or connected with such business, including the purchase, consruction and/or development of spectator bleachers, concession stands, track facilities and other related improvements.
- 2. To purchase and acquire, through issuance of its capital stock or otherwise, and to own, hold, lease, either as lessor or lessee, sell, exchange, subdivide, mortgage, deed in trust, operate, plant, improve, cultivate, develop, landscape, construct, maintain, equip and generally deal in any and all types of real estate, improved or unimproved, and any and all other types of property, real or personal, of every kind and descriptions wheresoever situated.
- 3. To manufacture, produce, purchase or otherwise acquire, invest in, own, mortgage, pledge, sell, assign,

transfer or otherwise dispose of deal in any and all items of personal property, including, but not limited to, equipment, vehicles, horses, supplies and materials related to or in any way associated with racing.

- 4. To act as general contractor or subcontractor on all types of construction projects, and to employ, engage and contract with or for architects, engineers, consultants and building contractors.
- 5. To make, enter into, perform and carry out contracts of every kind and nature, including, but not limited to, contracts and agreements of partnership and joint venture with any person, firm, association, corporation or other legal entity for the purpose of engaging in any and all kinds of lawful business enterprises and ventures.
- 6. To acquire the good will, rights, property interests, franchises, options and assets of all other kinds and nature, and to undertake any part of the liabilities of any person, firm, association, corporation or other legal entity on such terms and conditions as may be agreed upon, and to pay for the same in cash, stocks, bonds, debentures, or other securities of this corporation or otherwise.
- 7. To incur debt and to borrow, and to secure the payment of money in any lawful manner, including the issuance of bonds, warrants, debentures, notes, or other evidences of indebtedness as may be necessary to accomplish and further the lawful activities of this corporation.
- 8. To acquire, by purchase, gift or otherwise, shares of its own stock, and to cancel the same or any part thereof, or to hold any or all of such stock for resale as treasury stock, or for the purpose of making stock dividends to its shareholders, and to restrict the transferability of its outstanding shares to the extent reasonably necessary to protect the interests and rights of the corporation and its shareholders.
- 9. Without limiting any of the foregoing objects, purposes of powers, it is hereby expressly declared and provided that said corporation shall have the power to do all acts or things necessary, incidental or convenient for the promotion, either directly or indirectly, of the interests of the corporation, or to enhance the value or render profitable any of its property or rights; and in carrying on its business, or for the purpose of obtaining and furthering any of its objects, as hereinabove defined and specified, and to do any and all acts and things which now or hereafter be authorized by law.

10. The enumeration in this Article of the Purposes and Powers of this corporation shall not be held to limit or restrict, in any manner, the general powers conferred upon business corporations by the laws of the State of Idaho, all of which powers and purposes are hereby expressly claimed.

ARTICLE III

Duration

The corporation shall have perpetual existence.

ARTICLE IV

Registered Office

The registered office of the corporation shall be located in Twin Falls, Twin Falls County, State of Idaho, and the post office address of said registered office shall be 2144 Hillcrest Lane, Twin Falls, Idaho, 83301.

ARTICLE V

Registered Agent

The registered agent for the corporation, for the purpose of receiving notices and service of process, shall be Stephen York, 2144 Hillcrest Lane, Twin Falls, Idaho, 83301.

ARTICLE VI

Stock

The capital stock of this corporation shall be composed entirely of stock of no par value, and the authorized number of shares of no-par-value stock shall be 5,000, which stock shall be common stock, nonassessable, and of one class.
