
CERTIFICATE OF AMENDMENT OF

Pursuant to resolution of the sole shareholder and director adopted on June 15, 1993, the Articles of Incorporation of Paragon Plumbing, Inc., an Idaho corporation, filed of record on July 17, 1991, are hereby amended and restated in their entirety, as follows:

FIRST

The name of the corporation is PARAGON PLUMBING, INC.

SECOND

The period of its duration is perpetual.

THIRD

The purpose for which the corporation is organized is for the transaction of any or all lawful business for which the corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is 1,000 with a par value of \$1.00 per share.

FIFTH

Shareholders shall have a preemptive right to acquire unissued or treasury shares or securities convertible into such shares or carrying a right to subscribe to or acquire shares, except as provided in the Idaho Business Corporation Act.

SIXTH

The location of the initial registered office of the corporation is 9045 McMillan Road, Boise, ID 83704, and the name of its initial registered agent at such address is Robert L. Albrecht.

SEVENTH

The corporation shall have not less than one (1) nor no more than seven (7) directors on its Board of Directors. The number of directors constituting the initial Board of Directors is one (1), and the name and address of the person who is to serve until

the first annual meeting of the shareholders and until his successor is elected and qualified is:
