The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation.

I

The name of the Corporation is ROCKY MOUNTAIN SILENT CORPORATION.

II

The period of its duration is perpetual.

III

The purpose for which this Corporation is organized is for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
