ARTICLES OF INCORPORATION
of
SAUREY CONSTRUCTION, INC.

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

1. **Name.**

The name of the corporation is: Saurey Construction, Inc.

2. **Duration.**

The corporation shall have perpetual duration.

3. **Purposes.**

The corporation is formed primarily for the purpose of construction and for any and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

4. **Authorized Shares.**

The corporation shall be authorized to issue 1,000 shares, all of one class, with a par value of one hundred dollars (\$100.00) per share.

6. Directors.


