

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: NAME

The name of the corporation is Steve Henderson Logging, Inc.

SECOND: DURATION

The period of its duration is perpetual.

THIRD: PURPOSE

The purpose or purposes for which the corporation is organized are: For the contracting of logging, ownership of real property, farming and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Act.

FOURTH: SHARES

It shall have the authority to issue 100,000 shares of stock all of one class of \$1.00 par value.


