ARTICLES OF INCORPORATION OF SOLDIER CREEK RANCH, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each and all being natural citizens of full age have this day and do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

ARTICLE I.

The name of this corporation shall be:

SOLDIER CREEK RANCH, INC.

ARTICLE II.

The purpose and objects for which this corporation is formed are:

1. To generally engage in, do and perform any enterprise, act or vocation permitted or authorized pursuant to the provisions of the Idaho Business Corporation Act and amendments thereto.

ARTICLE III.

This corporation shall have a perpetual existence.

ARTICLE IV.

The total number of shares which the corporation is authorized to issue is One hundred thousand (100,000). The aggregate par value of such shares is One million (1,000,000) and the par value of each share is Ten dollars (\$10.00).

ARTICLE V.

There are no provisions granting or denying preemptive rights.

ARTICLE VI.
