TAYLOR all being citizens of the United States and residents of the State of Washington, being desirous of forming a corporation for the purposes herein specified, and in conformity with the laws of the State of Washington, do make and subscribe the following Articles of Incorporation in triplicate.

#### ARTICLF I

The name of this corporation shall be: PRFEWAY REALTY, INC.

#### ARTICLE II

The period of existence and duration of this comporation shall be fifty (50) years.

#### ARTICLE III

The principal office of this corporation shall be: 6404 E. Sprague, in the City of Spokane, County of Spokane, State of Washington and the board of directors shall have the right to make By-Laws.

#### ARTICLE IV

The objects and purposes for which this corpo ation is organized and the nature of the business to be carried on by it are stated to be as follows, to-wit:

To purchase, lease from others, and otherwise acquire, construct, improve, mortgage, sell, exchange, convey, transfer, lease to others or otherwise dispose of, real or personal property in its own name, in the name of others, on consignment or otherwise.
