The undersigned, ALLAN CRAMER, being qualified as an incorporator of a corporation under the Idaho Business Corporate Act, of legal age, enters into these Articles for the purpose of forming a corporation under the laws of the State of Idaho, and does hereby make, adopt, execute, and acknowledge these Articles of Incorporation as follows:

ARTICLE I: Corporate Name

The name of the corporation shall be ALLAN CRAMER LOGGING, INC.

ARTICLE II: Shares

The corporation shall have authority to issue 500,000 shares of common voting stock.

ARTICLE III: Initial Registered Office and Registered Agent

The initial registered office of the corporation shall be located at 4550 Woodland Drive, Sandpoint, Idaho 83864. The initial registered agent at the address shall be ALLAN CRAMER.

ARTICLE IV: Initial Board of Directors

The number of directors of this corporation shall be not less than one nor more than nine. The initial Board of Directors of this corporation shall consist of one board member, who shall be ALLAN CRAMER, whose address is 4550 Woodland Drive, Sandpoint, Idaho 83864, who shall be the initial chairperson of the Board of Directors, and who shall serve as the Board of Directors until the first annual meeting of shareholders or until the successor(s) has been elected and qualified.

**ARTICLE V: Incorporator**

**ARTICLE VI: Corporate Purpose**

**ARTICLE VIII: Preemptive Rights**

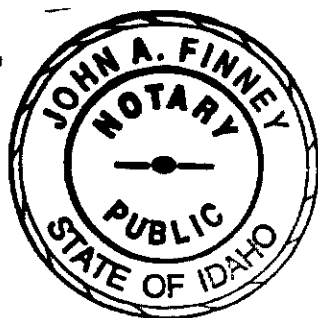
All shareholders are entitled to preemptive rights.
