## ARTICLES OF MERGER



 Pursuant to the previsions of Sections 63, 64, 65, 66, and 67 of the Wyoning Ensiness Corporation Act, the undersigned, MARKHAM ADVERTISING COMPANY, INC., a Wyoning corporation, with its principal place of business in Casper, Wyoning, and MIDWEST OUTDOOK ADVERTISING COMPANY, INC., a Wyoning corporation, with its principal place of business in Casper, Wyoning, adopt the following Articles of Merger for the purpose of merging them into one such corporation.
