BOISE CASCADE CORPORATION, a corporation organized and existing under the General Corporation Law of the State of Delaware (hereinafter called "Corporation"), does hereby certify as follows:

1. That the following amendment of the Certificate of Incorporation of the Corporation, as heretofore amended, has been duly adopted in accordance with the provisions of Section 242 of Title 8 of the Delaware Code:

"The Certificate of Incorporation of the Corporation as heretofore amended, is hereby further amended as follows:

1. The first paragraph of Article Fourth is hereby amended to read as follows:

'FOURTH: The total number of shares of all classes of stock which the corporation shall have authority to issue is eighteen million (18,000,000), of which three million (3,000,000) shares without par value are to be of a class designated

Preferred Stock, and fifteen million (15,000,000) shares of the par value of \$2.50 each are to be of a class designated Common Stock.'

- Each share of Common Stock of the par value of \$5 per share of the corporation issued and outstanding or held in the treasury of the corporation immediately prior to the time this amendment becomes effective shall be, and hereby is, automatically changed (without any further action of the corporation or its stockholders) into two fully paid and non-assessable shares of Common Stock of the par value of \$2.50 a share of the corporation.
- No holder of Common Stock shall have any preemptive right whatever to subscribe for, purchase or otherwise acquire shares of the corporation of any class authorized by this Article Fourth as amended."
- That the capital of the Corporation will not be reduced under or by reason of the foregoing amendment.


