EXHIBIT A ARTICLES OF INCORPORATION HISPANIC REAL ESTATE PROFESSIONALS, INC.

ARTICLE 2

The purpose for which this corporation is organized is: To provide public service, education and mutual support to the real estate industry and to the communities served, and to be duly educational and charitable in its purposes, within the meaning of Section 50l(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 50l(c)(3).

ARTICLE 8

Upon dissolution, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, distribute all of the assets of the corporation, consistent with the purposes of the corporation, to such other organization or organizations as shall at the time qualify as exempt organizations under Section 50l(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes, or to such organizations as such Court shall determine to be consistent with the purposes of the corporation.
