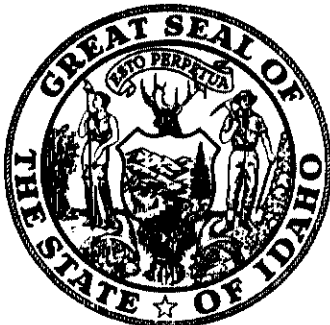

Article I. shall read: The name of this corporation shall be Adhara Technologies, Inc.




All other provisions of the original Articles of Incorporation shall remain the same.
