ARTICLES OF INCORPORATION FIRST CHURCH OF GOD OF JEROME, IDAHO, INC.

(a religious corporation)

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, desiring to form a religious corporation pursuant to the laws of the State of Idaho, hereby certify as follows:

- 1. NAME. The name of the corporation hereinafter referred to as the corporation shall be "FIRST CHURCH OF GOD OF JEROME, IDAHO, INC."
- DURATION OF CORPORATION. The duration of the corporation shall be perpetual.
- The purposes for which the corporation is PURPOSES. formed are: to carry on the religious and benevolent functions of the First Church of God, which functions are similar to and patterned after the practices of the area and State First Church of God Corporations, which corporations are affiliated with the general church offices in Anderson, Indiana; to hold religious services for the worship of God and teaching of its members in the principals of the church; to carry on any and all of the usual and ordinary functions of religious organizations; to conduct charitable activities and all the other usual church services.

The corporation shall also have the power to own, purchase, mortgage, lease, sell and otherwise deal in real property for church purposes; to take real and personal property mortgages and to engage in other types of real estate transactions deemed necessary for the business of the corporation; to make collections of accounts; to make and enter into all necessary contracts in connection with its business with any person, partnership, association or corporation and to carry out, assign, cancel or rescind any such contracts; to exercise all and any of the corporate powers authorized by the laws of the State of Idaho.

- OWNERSHIP OF CORPORATION. The corporation shall be non-profit, there shall be no stock or certificate of stock.

- 6. PLACE OF BUSINESS. The place of business of the corporation shall be at the meeting house at 4th Avenue East and Davis in the City of Jerome, Jerome County, Idaho, or at such other addresses or places within the State of Idaho as the Board of Trustees may from time to time designate.
- The business of the corporation shall 7. MANAGEMENT. be under the control and management of the Board of Trustees. Any three members of the Board of Trustees shall constitute a quorum at any meeting of the Board of Trustees. Issues shall be determined by vote of the Board of Trustees, each member having one vote.
