ARTICLES OF AMENDMENT OF STATE

We, the undersigned, president and secretary of Burgess Canal and Irrigating Company, do hereby certify:

- The name of the corporation is Burgess Canal and Irrigating Company.
- 2. The amendments to the Articles of Incorporation of Burgess Canal and Irrigating Company, are as follows:
 - A. That Article 4. shall be amended to read as follows:

ARTICLE 4.

The time of existence of this corporation shall be perpetual.

B. That a new Article designated 8. be added as follows:

ARTICLE 8.

This corporation is a non-profit corporation.

C. That a new Article designated 9. be added as follows:

ARTICLE 9.

All outstanding shares of the corporation shall continue to be assessable for payment of the obligations of the corporation in the manner and to the extent provided in the By-Laws of the corporation and as said By-Laws may from time to time be amended.

D. That a new Article designated 10. be added as follows:

ARTICLE 10.

The capital stock of the corporation may not be transferred except in connection with a transaction involving title to the real property to which that proportion of the water and conveyance rights of the corporation represented by such stock is appurtenant, or as otherwise provided by the By-Laws of the corporation, and only to the extent and in the manner provided in said By-Laws and as the same may from time to time be amended.

That a new Article designated 11. be added as E. follows:

ARTICLE 11.

Those shareholders present at an annual or special shareholders' meeting shall constitute a quorum for purposes of transacting any business before the meeting.

- The foregoing amendments to the Articles of Incorporation 3. were adopted and approved at the annual meeting of the shareholders of Burgess Canal and Irrigating Company, on March 6, 1981.
- There are 4.000 shares outstanding of Burgess Canal and Irrigating Company, and the same number of shares is entitled vote on amendments to the Articles of Incorporation.
- At the annual meeting of shareholders of Burgess Canal 5. and Irrigating Company, held on March 6, 1981, 750.8 shares of stock voted in favor of the foregoing amendments to the Articles of Incorporation of Burgess Canal and Irrigating Company, and 371.3 voted against said amendments.
- Said amendments do not provide for exchange, reclassification or cancellation of issued shares.
