The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is ECHO BAY ROAD IMPROVEMENT ASSOCIATION, INC.

SECOND: The period of this corporation's duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to conduct the business of maintaining a roadway servicing its shareholders real property and collecting and disbursing funds of the shareholders. This corporation shall be non-profit.

FOURTH: Provisions denying preemptive rights are: Pursuant to the By-Laws.

FIFTH: The aggregate number of shares which the corporation shall have authority to issue is 100 shares of the par value of \$1.00.

SIXTH: Provisions for the regulation of the internal affairs of the corporation: Pursuant to By-Laws.
