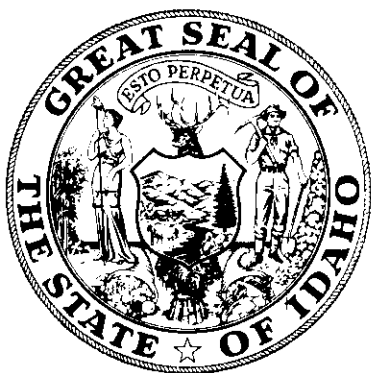



The name of the Corporation is XEDAR SALES CORPORATION.




