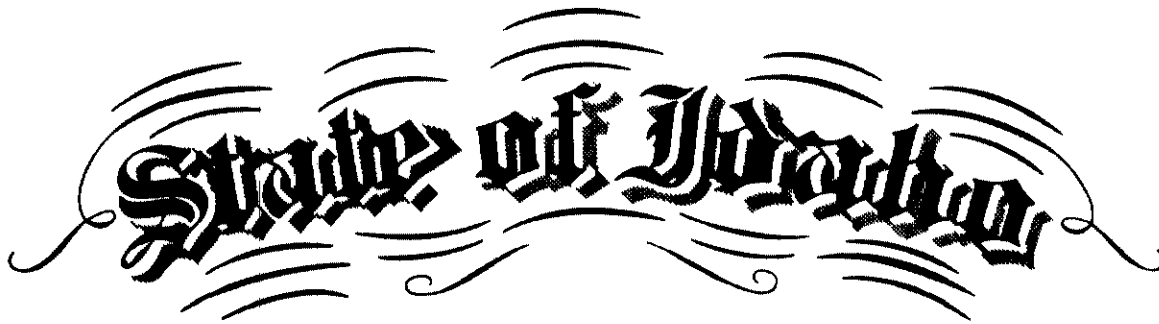

ARTICLES OF INCORPORATION

OF

ZIMMERMAN LOGGING, INC.

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation:

ARTICLE I

The name of the corporation is Zimmerman Logging, Inc.

ARTICLE II

The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act. Further, to engage in the general lumber business, including timber, milling, and allied interests, together with the building of logging roads, and other things necessary in the full and complete operation thereof; to engage in a general lumber, timber, kiln drying, milling, construction materials, and merchandise business; to manufacture, purchase, or otherwise acquire, sell, or otherwise dispose of logs, lumber, wood products in a processed or unprocessed state, and by-products of wood or of said manufacturing operations, and building and construction supplies and merchandise, either at wholesale or retail; to engage in the business of hauling and transporting logs, timber, lumber, lumber products, and other freight, goods, wares, and merchandise, by means of trucks and other forms of transportation, over public or private highways, or roads; and to do such other things as are incidental, or necessary, to the carrying on of such business.

ARTICLE III

The period of duration of the corporation is perpetual.

ARTICLE IV

The address of the corporation's initial registered office in the State of Idaho is Route 1, Box 49D, City of Troy, County of Latah, State of Idaho 83871. The name of the corporation's initial registered agent at such address is Bernal Zimmerman.

ARTICLE V

The total authorized number of par value shares of stock is 10,000 shares having a par value of \$1.00 per share. The aggregate par value of the total authorized number of par value shares is TEN THOUSAND and NO/100 DOLLARS (\$10,000.00). The total authorized number of shares without par value is none. All stock of the corporation shall be common stock.

ARTICLE VI

Pursuant to Idaho Code 30-1-26, the shareholders shall have the preemptive right to acquire unissued or treasury shares or securities convertible into such shares or carrying a right to subscribe to or acquire shares. The provisions of Idaho Code 30-1-26 as amended from time to time shall be controlling with respect to preemptive rights of shareholders.

ARTICLE VII

The number of directors constituting the initial board of directors is one (1) and the name and address of the person who is to serve as director until the first annual meeting of the shareholders or until his successor is elected and qualify is:
