# ARTICLES OF INCORPORATION

POSTLEWALT CONSTRUCTION AND RIGGING CO. BY ASSISTANT SUPERVISION OF CORPORATIONS

We, the undersigned, all of whom are of legal age, residents of the State of Washington, and citizens of the United States, do hereby associate ourselves for the purpose of forming a Corporation and for that purpose execute these Articles of Incorporation, in triplicate originals.

#### ARTICLE I

The name of the Corporation shall be Postlewait Construction and Rigging Co.

### ARTICLE II

The objects and purposes for which this Corporation is formed are:

- (a) To engage in the construction and rigging business in all of its variations and to acquire, own, operate, lease, and dispose of any property necessary or desirable to carry on such business.
- (b) To engage in the logging business in all its variations and to acquire, own, operate, lease and dispose of any property necessary or desirable in carrying on such business.
- (c) To engage in the business of transporting persons or property for hire by any means of conveyance, as a common carrier, contract carrier, or otherwise, and to acquire, own, operate, lease and dispose of any property necessary or desirable to carry on such business.
- (d) To acquire, own, mortgage, pledge, sell, rent, assign and transfer or otherwise dispose of, to invest, trade, deal in and deal with real or personal property of every class and description.
- (e) To borrow money and pledge its assets as security therefor, and to loan money and obtain from the borrower pledges of the borrowers assets as security therefor.
- (f) To generally engage in any business that a natural person might or could do or perform except such acts which a corporation specifically is forbidden by the laws of the State of Washington to do.
