ARTICLES OF INCORPORATION

KNOW ALL PERSONS BY THESE PRESENTS:

The undersigned, for the purpose of forming a non-profit corporation under the laws of the State of Idaho in compliance with the provisions of Title 30, Chapter 3, <u>Idaho Code</u>, does hereby certify, declare and adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be SPRING CREEK NEIGHBORHOOD ASSOCIATION, INC. (the "Spring Creek Association").

ARTICLE II TERM

The period of existence and duration of the life of the Spring Creek Association shall be perpetual.

ARTICLE III NON-PROFIT

The Spring Creek Association shall be a non-profit, membership corporation.

ARTICLE IV REGISTERED AGENT

The location and street address of the initial registered office of the Spring Creek Association shall be 1025 S. Bridgeway Place, Suite 280, Eagle, Idaho 83616, and Thomas M. Coleman, Jr. is hereby appointed the initial registered agent of the Spring Creek Association.

ARTICLE V PURPOSE AND POWERS OF THE SPRING CREEK ASSOCIATION

The Spring Creek Association does not contemplate pecuniary gain or profit to the Members thereof, and the specific purposes for which the Spring Creek Association is formed are to provide for certain regulations of the use of the Lots in the Spring Creek Neighborhood and to exercise all of the powers and privileges and perform all of the Spring Creek Association's duties and obligations as set forth in the Spring Creek Phase I Supplement to the Master Declaration of Covenants, Conditions and Restrictions for West Highlands Ranch Subdivision, recorded in the official records of Canyon County, Idaho, as Instrument No. 2008 060 222, and within any amendments or supplements thereto (collectively, the "Spring Creek Supplement"), the Master Declaration of Covenants, Conditions and Restrictions for West Highlands Ranch Subdivision, recorded in the official records of Canyon County, Idaho, as Instrument No. 2008 060 221, and within any amendments or supplements thereto (collectively, the "Master Declaration"), and the Project Documents identified therein including, without limitation, the following powers:

- (a) Fix, levy, collect and enforce payment by any lawful means of all charges or Assessments pursuant to the terms of the Master Declaration and the Spring Creek Supplement and all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Spring Creek Association;
- (b) Acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Spring Creek Association under the limitations imposed by the Master Declaration or Spring Creek Supplement;
- (c) Borrow money, and mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- (d) Participate in mergers and consolidations with other non-profit corporations organized for the same purposes or annex additional residential property, provided that any such merger, consolidation or annexation shall comply with the requirements of the Master Declaration and the Spring Creek Supplement; and
- (e) Have and exercise any and all powers, rights and privileges which a corporation organized under the Idaho Nonprofit Corporation Act may by law now or hereafter have or exercise, subject only to limitations contained in the Bylaws, the Master Declaration, the Project Documents, the Spring Creek Supplement and any amendments and supplements thereto.

ARTICLE VI MEMBERSHIP

During the existence of this corporation, every Owner of a Lot in the Spring Creek Neighborhood, including Grantor, shall be a Member of the Spring Creek Association. No Owner of a Lot in the Spring Creek Neighborhood shall have more than one membership in the Spring Creek Association for each Lot owned.

ARTICLE VII VOTING RIGHTS

The Spring Creek Association shall have two (2) classes of memberships:

- (a) <u>Class A Members</u>. Class A Members shall be the Owners of Lots within the Spring Creek Neighborhood, excluding Grantor for so long as Grantor is the Class B Member. Upon the Class B Member Termination Date (defined below), at all meetings of the Spring Creek Association each Class A Member will be entitled to one (1) vote for each Lot within the Spring Creek Neighborhood owned by such Member. Upon the Class B Member Termination Date, to the extent Grantor owns a Lot within the Spring Creek Neighborhood, Grantor shall become a Class A Member and shall be entitled to one (1) vote for each Lot owned by Grantor within the Spring Creek Neighborhood.
- (b) <u>Class B Member</u>. Grantor, by and through Grantor's designated representative (hereinafter "Grantor's Delegate"), shall be the Class B Member, and shall be the sole voting member of the Spring Creek Association entitled to vote the collective voting power of the Spring Creek Neighborhood until the Class B Member Termination Date. The Class B Member shall cease to be a voting Member in the Spring Creek Association upon the earlier to occur of the following: (i) the date upon which Grantor no longer owns any Lot within the Spring Creek Neighborhood; (ii) the date Grantor informs the Spring Creek Neighborhood Board in writing that Grantor no longer wishes to exercise its rights as the Class B Member, or (iii) June 1, 2020. This date may be referred to herein as the "Class B Member Termination Date."

ARTICLE VIII BOARD OF DIRECTORS

The affairs of the Spring Creek Association shall be controlled by the Board of Directors (individually "Directors") to carry out all of the powers and duties of the Spring Creek Association as set forth herein, and shall be selected as follows:

- (a) <u>Selection of Directors Prior to Class B Member Termination Date</u>. Until the Class B Member Termination Date, the Board shall consist of not less than three (3) Directors nor more than seven (7) Directors appointed by the Class B Member in the Class B Member's discretion. The Class B Member shall have the right to remove and replace any Director, with or without cause, in the Class B Member's discretion.
- (b) <u>Selection of Board After the Class B Member Termination Date</u>. Subsequent to the Class B Member Termination Date, the Board shall be elected by a majority of the Members of the Spring Creek Association. The number of Directors within the range set forth in subsection (a) above shall be established by resolution of the Board. The number of

Directors outside the range set forth in subsection (a) above may be changed by amendment of the Bylaws of the Spring Creek Association, but in no event shall the number be less than three (3).

ARTICLE IX ASSESSMENTS

Each Member shall be liable for the payment of Assessments pursuant to the Master Declaration and the Spring Creek Supplement and as set forth in the Bylaws of the Spring Creek Association.

ARTICLE X BYLAWS

The Bylaws of this Spring Creek Association may be altered, amended, or new Bylaws adopted at any regular meeting, or any special meeting of the Spring Creek Association called for that purpose, by the affirmative vote of more than fifty percent (50%) of the total voting power of the Spring Creek Association. For the purpose of specifying in detail the rights, responsibilities, duties and obligations of the Board of Directors, the officers, employees and agents of the Spring Creek Association, and the Members for the payment of Assessments, the Bylaws may incorporate by reference the provisions of the Master Declaration and the Spring Creek Supplement.

ARTICLE XI DISSOLUTION

The Spring Creek Association shall only be dissolved at a regular meeting, or a special meeting of the Spring Creek Association called for that purpose, by the affirmative votes of no less than two-thirds (2/3) of the total voting power of the Spring Creek Association. Upon dissolution of the Spring Creek Association, other than incident to a merger or consolidation, the real property and other assets of the Spring Creek Association shall be distributed as follows: (i) dedicated to an appropriate public agency to be used for purposes similar to those for which the Spring Creek Association was created; or (ii) granted, conveyed and assigned to a non-profit corporation, association, trust or other organization to be devoted to such similar purposes.

Notwithstanding any other provisions of these Articles, the Spring Creek Association shall not carry on any other activities not permitted by any organization exempt from federal income tax under Section 528 of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States internal revenue law).

ARTICLE XII AMENDMENTS

Amendment of these Articles of Incorporation may be made at any regular meeting, or any special meeting of the Spring Creek Association called for that purpose, by the affirmative vote of more than two-thirds (2/3) of the total voting power of the Spring Creek Association as cast by the Members, and, if required by the Master Declaration or the Spring Creek Supplement, the consent of holders of first mortgages on Lot(s) who have requested in writing that the Spring Creek Association provide them notice of proposed actions which affect their interests. No amendment which is inconsistent with the provisions of the Master Declaration, the Spring Creek Supplement or the Project Documents shall be valid.

ARTICLE XIII MEANING OF TERMS

Except as otherwise defined herein, all terms appearing herein initially capitalized shall have the same meanings as are ascribed to such terms in the Master Declaration or the Spring Creek Supplement.

ARTICLE XIV INCORPORATION

Thomas M. Coleman, Jr. shall be the incorporator of the Spring Creek Association.
