

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS that ROBERT M. LEAHY, STEVEN W. RIESER and JEFFREY D. GRIFFIN, all being over the age of 18 years, and for the purpose of forming a corporation under the Idaho Nonprofit Corporation Act, hereby certify and adopt in duplicate the following Articles of Incorporation.

ARTICLE 1. CORPORATE NAME

1.1 The name of the Corporation (hereinafter called "Corporation") is PALOUSE PRACTICAL SHOOTERS, INCORPORATED.

ARTICLE 2. DURATION AND FISCAL YEAR

2.1 The duration of this Corporation shall be perpetual.

2.2 The fiscal year of this Corporation shall begin on May 1 and end on April 30.

ARTICLE 3. PURPOSES AND POWERS

3.1 This Corporation is not organized for profit and no part of gains or earnings shall enure to its members. It is the specific purpose of this Corporation to provide supervised facilities in the community for the development of good firearms marksmanship, instruction in the safe handling and proper care of firearms and to provide an adequate area for safe shooting. The Corporation is further authorized to do and engage in all other lawful activities that are in furtherance of one or more of the beforementioned purposes. Notwithstanding any other provision of

these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a Corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future Tax Code.

ARTICLE 4. MEMBERS AND MEMBERSHIP

4.1 Participation in management and ownership of the Corporation shall be membership only. The Corporation shall issue no stock and shall have no shareholders, but shall have members.

4.2 The qualifications, classes and rights of members are set forth in the Bylaws of this Corporation.

ARTICLE 5. INITIAL REGISTERED OFFICE AND AGENT

5.1 The initial registered office of the Corporation shall be at 212 N. Cleveland St., Moscow, Idaho, 83843, and the initial registered agent at such address shall be STEVEN W. RIESER.

ARTICLE 6. BOARD OF DIRECTORS

6.1 The affairs of this Corporation shall be managed in accordance with the Bylaws by a Board of not less than three (3) nor more than ten (10) Directors. The names and addresses of the incorporators of the Corporation, who shall also act as the initial Directors of the Corporation, until the selection of their successors, are:

ARTICLE 7. DISSOLUTION

7.1 In the event of dissolution, liquidation, or winding up of the Corporation, after payment of, or adequately providing for, the debts and obligations of the Corporation, the Directors or persons in charge of liquidation shall distribute any remaining assets, properties, and/or money to original contributors. Any such assets not distributed shall be distributed by the Board of Directors of the Corporation to another similar nonprofit organization to be used in such a manner as will best accomplish the general purposes for which the Corporation was organized.
