

ARTICLES OF INCORPORATION

We, the undersigned, being more than twenty-five (25) citizens of Idaho and owners of insurable property in Canyon County, State of Idaho, do hereby associate ourselves together for the purpose of forming a County Mutual Fire Insurance Company in said County of Canyon according to the laws of the State of Idaho, and we hereby certify:

I.

The name of this Corporation shall be "CANYON COUNTY FARMERS MUTUAL FIRE INSURANCE COMPANY".

II.

The purposes for which said corporation is formed are as follows:

1. To insure the property of each other against loss by fire and lightning.
2. To insure the property of such other persons as may hereafter become members of the said corporation by complying with the constitution and By-Laws of this Corporation.
3. To assess and collect from each other and from the members of this corporation such sums of money as may be necessary to pay the losses by fire and lightning which may be sustained by the members of this corporation.
4. To issue policies of insurance to the members of this corporation according to the Laws of the State of Idaho, and the constitution and By-Laws of this corporation.
5. To pay such losses which may be sustained by any policy holder in the said corporation on account of loss of property by fire or lightning in the manner provided by the By-Laws of this corporation.

6 To pay such expenses as may be approved by the Board of Directors and to collect such expenses by assessing the policy holders of this Corporation in the manner provided in the By-Laws thereof.

7 To insure against loss by fire and lightning the following kinds of property, to-wit: * Dwellings and additions thereto, Barns, Stables, Graneries, Implement Houses and Sheds, Frame Cellars, Poultry Houses, Fruit Packing Houses, Tool Houses and Work Shop, House-hold furniture, Bedding, wearing apparel, provisions, Libraries, Musical instruments, Live Stock, Carriages, Harness and Farm Implements, Clover and Alfalfa Seed, Hay and Grain of farmers only while situated on farms in Canyon, Ada, and Washington Counties, in the State of Idaho, Country Churches, and their furniture and fixtures, Country School Houses, and their furniture and fixtures, of Canyon, Ada, and Washington Counties, State of Idaho, and not situated within the limits of any incorporated City, or Town; Provided, that no insurance shall be written on any of the above enumerated kinds of property outside of the boundaries of Canyon, Ada, and Washington Counties, State of Idaho.

III

The head office of the said Corporation shall be located at Parma, Canyon County, State of Idaho, and the principal place of business of said Corporation shall be at Parma, County and State aforesaid, and the said corporation proposes to do business in said Canyon, Ada, and Washington Counties only.

IV.

The term for which said Corporation shall exist shall be Fifty Years.

V.

The number of directors of the said Corporation shall be Nine (9) and those selected by the incorporators shall serve for one year when an election by the members of the corporation shall be held for the purpose of electing three members of the Board of Directors for a term of one year, three members for a term of two years and three members for a term of three years, and thereafter at each annual meeting there shall be elected three members of the Board of Directors for a term of three years each.
