ARTICLES OF AMENDMENT
(Non-Profit)
REAL LIFE MINISTRIES SILVER VALLEY, INC.

The text of each amendment is as follows.

Section Two: Purpose

The purpose for which the said corporation is formed is for teaching and spreading the Gospel of our Lord Jesus Christ and to provide for the fellowship of the local members of the Body of Christ which is the church of Christ; to acquire and to own and to retain and perpetuate property as may be necessary for the building of the church and for all other religious and charitable purposes properly attributable to a religious organization. Provided no jeopardy is created to its status as a corporation exempt from federal income tax under Section 501(c)3 of the Code, the Corporation shall be authorized to do any and all lawful acts which may be necessary and useful, suitable, or proper for the furtherance of the purposes of the Corporation; to engage in any lawful business or activities related thereto; and to engage in any lawful act or activity for which corporations may be organized under the Idaho Nonprofit Corporation Act, and which are not inconsistent with tax exempt entities operating under the Code. This corporation is not organized for profit. The corporation is organized exclusively for religious purposes under section 501(c) 3 of the Internal Revenue Code.

In addition the Corporation and its Directors shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code. No gift or grant will be accepted if it contains major conditions which would restrict or violate any of the Corporation's charitable, religious, or educational purposes or if it would require serving a private as opposed to a public interest.
