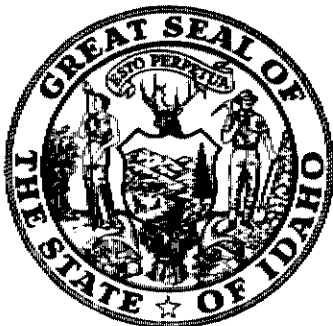

83, Idaho Code.


