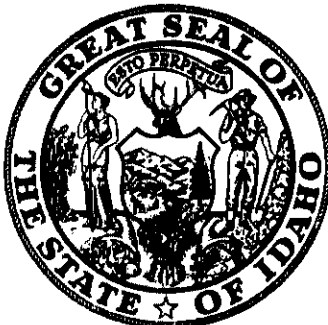

On Monday May 10, 1993 the members of the West Jefferson School District No. 253 Education Foundation Board met in Terreton, ID for the monthly meeting to amend the Articles of Incorporation. A quorum of the members was present and a majority voted in favor of the amendment.

Thus, the following amendment to the West Jefferson School District No. 253 Education Foundation Articles of Incorporation was approved on Monday, May 10, 1993.

ARTICLES OF AMENDMENT

WEST JEFFERSON SCHOOL DISTRICT NO. 253
EDUCATION FOUNDATION, INC.

ARTICLE IV

Section 3. Exempt Status. This corporation has not been formed for pecuniary profit or financial gain, and no part of the assets, income, or profit of the corporation is distributable to, or inures to the benefit of its trustees or officers except to the extent permitted under the Idaho Non-Profit Corporation Act. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, nor intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. This organization is organized exclusively for charitable and educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Revenue law) or

(b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law).

The power to amend these Articles of Incorporation is expressly conferred upon the members.
