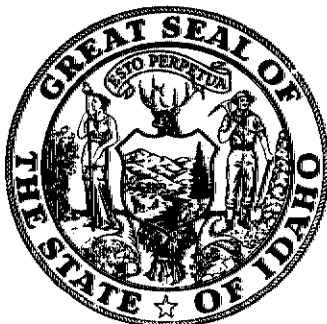

**ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of a corporation (hereafter referred to as "Corporation" under the Idaho business Corporation Act, adopts the following Articles of Incorporation for the Corporation:

**ARTICLE 1. NAME**

The name of the Corporation shall be **Lightning AirForce Corporation.**

**ARTICLE 2. REGISTERED OFFICE**

The location and post office address of the registered office of the corporation shall be 1268 Hill Road, Melba Idaho 83641.

**ARTICLE 3. REGISTERED AGENT**

The name or the registered agent of the corporation is Daniel L. MacPherson.

**ARTICLE 4. DURATION**

The period of existence and duration of the corporation shall be perpetual.

## ARTICLE 5. CORPORATION PURPOSE

The purpose for which the corporation is organized shall be the transaction of any and all lawful business for which corporations may be incorporated under the laws of Idaho.

## ARTICLE 6. AUTHORIZED SHARES

SECTION 1. NUMBER. The corporation shall have 10,000 shares of common stock with a par value of \$1.00 per share, for a total capitalization of \$10,000.00.

SECTION 2. DIVIDENDS. The holders of the common stock shall be entitled to receive, when and as declared by the Board of Directors, as permitted by the Idaho Business Corporation Act, dividends or distributions payable either in cash, property, or in shares of stock of the Corporation.

SECTION 3. STOCK NONASSESSABLE. The private property of the shareholders of the Corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and shares of the Corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the Corporation.

SECTION 4. VOTING POWER. The entire voting power for the election of the Directors and for all other purposes shall be vested exclusively in the holders of common stock, who shall be entitled to one vote for each share of common stock held by them of record.

#### ARTICLE 7. BOARD OF DIRECTORS

The number of Directors of the Corporation shall be as specified in the Bylaws. The number of Directors constituting the initial Board of Directors is one (1), and the name and address of the person who is to serve as Director until the first annual meeting of shareholders or until their successors are elected is:

#### ARTICLE 8. BYLAWS

The Board of Directors, by majority vote, shall have the power to adopt bylaws, and to repeal and amend Bylaw.

#### ARTICLE 9. EXISTENCE

The effective date for the first day of existence of the corporation shall be **January 2, 1995.**
