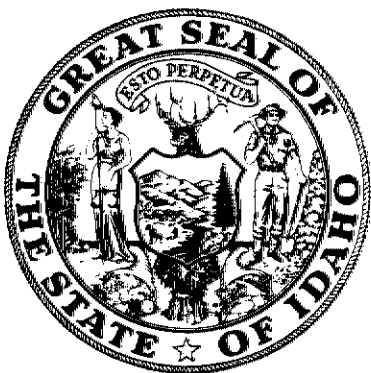

ARTICLES OF AMENDMENT

These Articles are being filed pursuant to Idaho Code § 30-1-61 to comply with all provisions thereof, and to amend the First Article of the Articles of Incorporation, specifically:

1. The name of the corporation is U.S.A. Fast Lube of Idaho, Inc.
2. The Amendments adopted by the corporation and approved by the corporate officers and the shareholders are as follows:
 - A. That the name of the corporation shall be amended from U.S.A. Fast Lube of Idaho, Inc. to USA Fast Lube of Idaho, Inc., reflecting deletion of periods in the name "USA".
3. Said amendment was adopted by the shareholders and the Board of Directors of the corporation on the 31st day of May, 1988.
4. The corporation has 500 shares outstanding with 500 shares entitled to vote on the same, all shares being common stock with a par value of \$1.00 each.
5. The voting was unanimous with all shares voting in the affirmative for said name change.
6. These Amendments were reviewed and accepted by all parties unanimously as noted herein.
