To engage in all activities in which a corporation can lawfully participate under the laws of the State of Oklahoma as now existing or hereafter enacted;

To operate, manage, supervise, and otherwise carry on all or any of the business of wholesale or retail outlets for the sale or exchange of golf equipment, clothing, paraphernalia, supplies, accessories, and other such articles and commodities and, generally, to deal in any and all aspects of the business of retail and wholesale golf outlets.

To act as a consultant on behalf of others and to assist others in the site selection, the lease negotiation, training, inventory preparation, retail merchandising, marketing, sales techniques, advertising, media relations, administrative procedures, store operations, computer inventory operations, accounting inventory procurement, store design and to otherwise assist in any manner relating to the opening of a retail or wholesale business engaged in the sale of golf equipment, clothing, paraphernalia, supplies, accessories, and other such articles and commodities.

To buy, sell, establish, supervise, operate, manage, and otherwise deal in the business of franchised retail or wholesale golf outlets, including but not limited to, the creation and sale of franchises, the establishment of franchise territories, the licensing of franchises, and otherwise acting as a franchisor.
