KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being persons of legal age, have this day voluntarily associated ourselves for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and to that and hereby adopt Articles of Incorporation as follows:

I.

The name of the corporation is COUNTRY COVE DEVELOPMENT, INC.

II.

The nature of the business of the corporation and the objects to be transacted, promoted, or carried on by it are:

- A. To engage in any lawful act of activity for which corporations may be organized under The Business Corporation Act of Idaho.
- B. The provisions of this Article shall be construed both as purposes and powers and each as an independent purpose and power. The corporation shall have perpetual existence.

IV.

The private property of the shareholders of the corporation shall not be subject to payments of corporation debts to any extent whatsoever.

v .

The registered office of the corporation is at 7360 Highway 95 South, Sandpoint, Idaho 83864 and its registered agent is Irwin R. Abell.

VI.

The aggregate number of shares which the corporation shall have authority to issue is 400,000 shares of one class only and each share shall be without par value. All of said stock shall be common stock and non-assessable having equal voting rights, powers, preferences, and restrictions; each of said shares shall be in all respects equal to every other share.

VII.

The business of the corporation shall be managed by its Board of Directors. The number of directors constituting the entire Board shall be no less than two (2); and subject to such minimum, may be increased to no more than five (5), and may be increased or decreased from time to time by amendment of the Bylaws in a manner not prohibited by law. Until so changed, the number shall be two (2).
