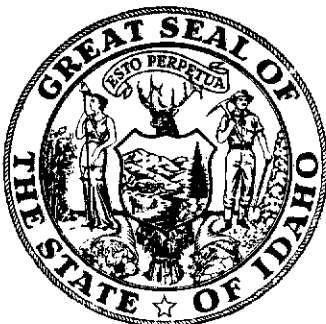

**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Professional Service Corporation Act, adopt the following Articles of Incorporation.

**ARTICLE ONE  
NAME**

The name of the corporation is NEW DAY MENTAL HEALTH SERVICES, P.A..

**ARTICLE TWO  
PURPOSE**

The purposes of the corporation are to engage in any and all lawful business for which corporations may be organized under the Idaho Professional Service Corporation Act including, but limited to, providing mental health counseling and mental health related services to their patients.

DURATION**
