




The amount of the capital stock of this corporation shall be Twenty-two thousand dollars, divided into two hundred and twenty shares of the par value of one hundred dollars each

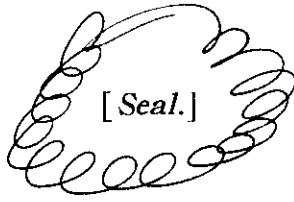

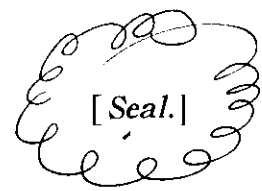
