

regularly scheduled meeting on November 8, 1993.

SECRETARY OF STATE

ARTICLE I.

The names of the corporation will be changed from Idaho Transit Association, Inc. to Community Transit Association of Idaho, Inc.

ARTICLE II.

The principal place of business shall be changed to: 1112 E. Chicago, Caldwell, Idaho 83605. The registered Agent shall be: Alice F. Reyes.

ARTICLE IV.

The purpose shall be changed to: To promote and support effective, public transportation to take any actions legal and proper throughout Idaho, and to especially promote and support accessible and acceptable public transportation. To afford all individuals to exercise their right to accessible mobility, for maintaining their independence, dignity and self sufficiency.

ARTICLE VI. MEMBERSHIP

Shall solely read: The membership of this association shall be as addressed in the bylaws of the Corporation.

ARTICLE VII BOARD OF DIRECTORS

Delete: Directorships are for staggered terms of two years, beginning and ending with the annual meeting. the Directors shall establish regular periodic meetings as are deemed necessary and special meetings may be held at the call of the President or at the request of two or more members.

Delete: The Board of Directors and the Incorporators are one and the same.

ARTICLE VIII

Amend to read: Articles of Incorporation of the corporation may be repealed, amended, altered or new articles adopted at any annual meeting, or at any special meeting of the members of the corporation called for that purpose. Furthermore, the Directors of this Corporation shall have the power to repeal, amend, and alter

the bylaws of the Corporation, subject to incorporation laws of the State of Idaho.

ARTICLE IX

Amendment: Delete names and addresses of the incorporators.
Amend to read: The names and addresses of the Board of Directors, each of whom is entitled to one certificate of membership as provided in these Articles, valid until the next annual meeting, regardless of qualifications, are as follows:
