Paul Grant was polled by telephone, giving the following vote on the subjects of the meeting.

Due to the fact of AGRICULTURAL SERVICES Inc., already registered in the State of Idaho it will not be possible to use our corporate name, Agricultural Services of America, Inc., in Idaho. It was proposed by Greg Dabney that we register "BIO-ACTIVE FARMING CONCEPTS, INC.", as an assumed name in Idaho. It was further resolved that 'Agricultural Services of America, Inc., be the DBA, as an assumed name to operate under BIO-ACTIVE FARMING CONCEPTS, INC.,

This resolution passed unanimously.

It was proposed by Greg Dabney that AGRICULTURAL SERVICES of AMERICA, Inc., enter into negotiations to undertake a 504 underwriting, which underwriting will encompass the private offering that is currently underway. This private offering will conclude on or before July 19, 1997. Russell Graham to coordinate with Ken Lindbloom, a stock-broker in Medford, Oregon, on this underwriting.
